Minutes of Meeting held in Schoolroom, Jany. 5th 1895

I Mr Wellesley Taylor was elected chairman, on the motion of Mr W. Groom, seconded by Mr W. T. Hickson. (see below \*)

II Mr Hy. Gardner was elected vice-chairman, on the motion of Mr F. J. Field, seconded by Mr E. J. Jefferson.

III It was proposed by Mr Harding and seconded by Mr W. Groom that Mr D. Feasey be Clerk to the Council.

Proposed as an amendment that Mr J. Jefferson be Clerk of the Council until the annual meeting in April.

Proposer - Mr Jefferson

Seconder - Mr H. Gardner

On the motion being put Messrs Gardner, Jefferson & Field voted for the amendment, & Messrs Harding, Oldham, Groom & Hickson for the proposition.

Mr D. Feasey was therefore elected Clerk of the Council.

IV Resolved that the proper parish books be secured for the parish. Proposer Mr Hickson, seconder Mr Harding

V Proposed & seconded that a committee of 3: viz. Mr Gardner, Mr Harding & Mr Hickson do make a proposition for the standing orders, & move a Resolution.

VI Proposed by Mr Hickson, seconded by Mr Harding & carried, that inquiry into any parish charities, books or documents be left over until the next meeting,

VII Proposed by Mr Hickson & seconded by Mr Gardner that the meetings be held "in camera". Proposed as an amendment by Mt Oldham and seconded by Mr Harding "that the public be allowed to hear the discussion of the Council. On the motion being put to the meeting 2 voted for the amendment and 5 for the original proposition, the original proposition being therefore carried. Messrs Harding and Oldham voted for the amendment. Messrs Gardner, Groom, Hickson, Field & Jefferson voted for the original proposition.

VII It was proposed by Mr Harding and seconded by Mr Hickson that the next meeting be held on Jany. 28th at 7p.m.

This was carried unanimously.

\*I It was proposed as an amendment that Mr H. Coleman should be chairman of the Parish Council. Mr Harding made this proposition and Mr O. Oldham seconded.

This amendment was put to the meeting & lost. Then Mr Taylor was elected (see above).

Minutes of a Meeting of the Parish Council held on 29th day of January 1895 in the schoolroom

Mr Wellesley Taylor in the chair.

Councillors present - Messrs F. J. Field, H. Gardner, W. Groom, D. Harding, W. T. Hickson, E. J. Jefferson, O. Oldham.

I The chairman requested the Standing Orders for the council from the committee appointed at the last meeting. Mr D. Harding proposed and Mr H. Gardner seconded that the "standing orders for Parish Council by J. Wallis Davis" should be obtained and adopted as the standing orders of the council.

This was carried unanimously

II Mr W. T. Hickson proposed that the school manager be applied to for terms for fuel, lights etc used at meetings of Parish Council.

Mr Jefferson seconded & this was carried.

III Mr D. Harding proposed that the council serve a precept on the Overseers for a rate of one penny in the pound.

Mr Gardner seconded.

Mr E. J. Jefferson proposed as an amendment that the money affairs stand over for the present. Mr Field seconded, and the amendment was carried unanimously.

IV Mr E. J. Jefferson proposed that a committee of 3 be appointed to enquire into and ascertain what charities, properties & documents, etc belong to the Parish Council, and report to the next meeting. Mr Groom seconded.

It was agreed that Messrs Gardner, Harding & Oldham be the Committee.

Minutes of a Meeting of the Parish Council held in the schoolroom on the 15th day of March 1895

Mr Wellesley Taylor in the chair

Councillors present : Messrs H. Gardner, W. Groom, D. Harding, W. T. Hickson, E. J. Jefferson

I The chairman drew the attention of the council to the death of Richard Littleboy Esq. who had consented to act as Treasurer. The council desired to show their sympathy & passed a voye of condolence with the family of the deceased. The chairman was desired and consented to convey the vote to Mrs Littleboy & family.

II The Charity Document committee reported that they had made careful enquiry respecting the award of the parish: and that the same was in the custody of Mr W. Makeham.

The council instructed the clerk to make application for it and to give a receipt for the same.

III (Marked) The chairman read a letter from Rev. E. Elton, suggesting that the council pay ten shillings per year for lighting & warming the schoolroom for the meetings of the council, the subscription to be paid in advance.

Mr Jefferson proposed, Mr Gardner seconded, & it was carried unanimously that these terms be accepted.

IV Mr Gardner proposed that a precept be made out for ten pounds, that this be served upon the overseers & the amount to be paid to the clerk of the council on march 21st 1895.

Mr Hickson seconded, & this was carried unanimously.

V Mr Jefferson proposed that the clerk be instructed to purchase a deed-box in which to keep all the books belonging to the council. Mr Harding seconded and the motion was passed unanimously.

VI Mr W. T. Hickson proposed that the Parochial electors be allowed to inspect the books belonging to the council at the clerk's office from 9a.m. to 7p.m. This was seconded by Mr Groom, and carried unanimously.

VII Mr Jefferson proposed & Mr Harding seconded, that the clerk purchase all books & things for the council's use, and also a leather bag. This was carried.

## April 5th 1895

The above resolutions were considered to be satisfactory & signed

## Pages 6 - 7

Minutes of a Meeting of the Parish Council held in the schoolroom on April 5th 1895

In the absence of the chairman Mr H Gardner, the vice-chairman took the chair.

Councillors present : Messrs W. Groom, D. Harding, W. T. Hickson, F. J. Field, O. Oldham

I The Clerk presented a letter which he had received from Mr F. Collett.

After a short discussion the council was unanimously of the opinion that the letter was offensive and uncalled for. Mr W. T. Hickson proposed that a letter be signed by the council and forwarded to Mr Collett, demanding an apology. This was seconded by Mr D. Harding and carried unanimously.

II On the arrival of Mt Wellesley Taylor, the vice-chairman vacated the chair in his favour. The minutes of the last meeting were read and accepted by the council, with the exception of one motion: viz. the terms for the accomodation of the Council in the schoolroom. Mr W. T. Hickson proposed that the clerk be instructed to write to the school managers to ask why the council should be requested to pay the money in advance, & stating that the terms should come direct from the managers to the council. Mr Gardner seconded and the motion was unanimously carried.

It was agreed that the matter should stand over until the managers meet.

III The Chairman brought under the notice of the Council the Technical Education proposals of the Bucks County Council. It was decided to let the matter stand over until the next meeting.

IV Mr Gardner proposed that Fredk. Bassett Esq., banker of Leighton Buzzard be Treasurer for the Council. Mr Field seconded, and the proposition was unanimously carried.

The clerk was instructed to write and ask him if he would be so good as to accept the office.

V Mr W. T. Hickson proposed that the next meeting of the Council be open to Parochial electors, & that it be held at 7.15 in the evening.

Mr Harding seconded & this was unanimously carried.

VI The following were nominated as overseers: Messrs George Fleet, Isaiah Lucas, Henry George Rose, William Groom, James Hine

Proposed by Mr Harding seconded by Mr Jefferson that the minutes be passed as satisfactory

## 19th April 1895

Minutes of a Meeting of the Parish Council held in the School Room on the 19th April 1895.

The vice-chairman, Mr H. Gardner, took the chair.

Councillors present: Messrs F. J. Field, W. T. Hickson, W. Groom, D. Harding. E. J. Jefferson, O. Oldham

Mr W. T. Hickson proposed Wellesley Taylor Esq. as Chairman of the Council. Seconded by Mr D. Harding; voted and carried unanimously.

Mr O. Oldham proposed D. Feasey as Clerk to the Council at a salary of  $\pm 2$ -0-0 per year. Seconded by Mr W. Groom voted & carried unanimously.

Mr E. J. Jefferson proposed Mr Isaiah Lucas and Mr James Hine to be Overseers for the ensuing year. Seconded by Mr F. J. Field, voted, carried unanimously.

Mr W. Groom proposed Messrs E. J. Jefferson, F. J. Field be appointed Trustees for the Stonepit Close for year 1895. Seconded by Mr W. T. Hickson voted carried unanimously.

Mr D. Harding proposed Mr Joseph Hartup's offer of £2-15-0 for the year, for the Stonepit Close be accepted. Tenancy to commence at Michaelmas 1895. Seconded by Mr W. Groom, voted, carried by majority of 5 to 2.

Mr W. T. Hickson proposed that a precept be served on the overseers for £10-0-0.

Seconded by Mr E. J. Jefferson, voted, and carried by a majority of 5 to 2.

It was proposed that Mr F. Collett's Letter be accepted as an ample apology.

Mr W. T. Hickson proposed D. Feasey should have a salary of £1-0-0 for the year 1894 for the office of Constable. Seconded by Mr D. Harding, voted, carried unanimously.

It was proposed by Mr W. Groom seconded by Mr F. J. Field that D. Feasey be appointed Constable for the ensuing year. Carried unanimously.

Technical Education. It was proposed by Mr W. T. Hickson seconded by Mr F. J. Field the same committee ve asked to continue in office.

A committee was appointed, consisting of Mr D. Harding, Mr W. T. Hickson, Mr W. Groom to inquire into the desirability of purchasing property for the purpose of supplying a Public Room for the village.

A letter from the Technical Education Committee which stated they were willing to act in that capacity as before.

A letter from Rev. E. Elton respecting the Prepayment of the Annual Charge for the accomodation in the school room while the Parish Council and the Parish Meetings are being held. Proposed by Mr W. T. Hickson. Seconded by Mr E. J. Jefferson that the sum of ten shillings be paid to the School Managers as being their charge up to the 31st December 1895; voted for, carried unanimously.

The report of committee appointed to inspect property for the purpose of making a Public Room for the village of Sherington was given. After inspecting the property they found it was not suitable for that purpose. The question fell through. Proposed by Mr W. T. Hickson, seconded by Mr D. Harding that a committee of four be appointed to inquire into sanitary business and to report at the next meeting of the Council Namely Messrs H. Gardner, D. Harding, W. T. Hickson, E. J. Jefferson.

IV Mr H. Gardner proposed seconded by Mr F. J. Field Mr John W. Graves and Mr G. Sharman be elected Overseers for the ensuing year, voted, carried unanimously.

5 The Council unanimously elected Messrs F. J. Field & Mr O. Oldham Trustees of the Stonepit Close. The Council unanimously agreed to let the Stonepit Close for one year. Mr Joseph Hartup offer of Four pounds Twelve shillings and Sixpence £4-12-6 for the year for the Stonepit Close tenance to commence 29th Sept 1896, expire 29 Sept 1897, was accepted by the council.

6 The Council requested the Clerk to write to the Technical Education Committee aking them to continue in office and had to their number Mr D. Harding and Mr G. Watts.

7 Mr W. T. Hickson proposed, seconded by Mr G. Watts, that a short report of the Council Meetings be published this year in the news paper, voted, carried unanimously.

8 Mr D. Harding proposed, seconded by Mr J. Petts, the Sanitary Powers be applied for, voted for three in favour one against. The Clerk was instructed to write to the District Councillor ask him to bring the matter before the District Council at their next meeting.

That the lighting of the street lamps be discontinued on 21<sup>st</sup> February instant, and the opinion is expressed that the oil was not altogether satisfactory, the lamps in fact are inadequate and unfit for use in their present state, and it appears that new lamps will be necessary another season.

It is reported that the Coronation Committee have a scheme in hand for the acquisition of the Cottage on the Knoll, afterwards having same demolished

Proposed by Mr E J Jefferson and seconded by Mr F J Field:

That the Parish Council express the opinion that a public improvement would be made when the proposals of the Coronation Committee are carried out and they are glad to hear that the acquisition of the property is under the consideration of such Committee

## 9<sup>th</sup> March 1914

At a meeting of the Sherington Parish Council held at the Schoolroom this day

Present: Mr F J Field Chairman

Messrs E J Jefferson, I Slayter, J Petts and G J Hine (Councillors)

And Major Allfrey, Messrs W Weeks and G J Hine (Representing the Coronation Committee)

The minutes of the last meeting were read confirmed and signed by the Chairman

The Chairman explained that the meeting had been called together to consider the question of the Parish Council accepting the gift of the house and land on the Knoll and having the old house demolished and a public improvement thereby made, and asked Major Allfrey to report on the proposals of the Coronation Committee.

Major Allfrey reported that the Coronation Committee had acquired the property for £25 and they proposed to pull the old Cottage down, and had opened a subscription list for such a purpose. His Committee thought it best to have the property conveyed to the Parish Council rather than to any private individual. There was 5/6 Land tax payable on the premises which could be reduced to a nominal figure after the Cottage was demolished.

If the Parish Council accepted the gift his Committee would give an undertaking that the Cottage would be demolished and the site properly cleared, also a fence would be arranged for as a boundary of adjoining garden, and the property conveyed free. The Clerk reported that the Parish Council were empowered to accept and hold any gifts of property real or personal for the benefit of the inhabitants of the Parish or any part thereof.

Proposed by Mr E J Jefferson and seconded by Mr J Petts:

That it be recorded on the minutes that the Parish Council accept with many thanks the gift of the Sherington Coronation Committee of the old cottage and land lately in the occupation of Mr F James in the High St Sherington, and that same be held on behalf and for the benefit of the inhabitants of the Parish, provided that the Coronation Committee give a free conveyance of the same and an undertaking to have the old Cottage demolished and the site left clean and tidy within six months from date of conveyance

## Carried unanimously

The Chairman thanked Major Allfrey and the Coronation Committee for their kind attendance and report.
