MKHA members encouraged to submit ideas for future exhibitions and more heritage based events at library.

14.'EDI' - Discussion lead by Neil Loudon - (slides 21 to 30)

This element of the evenings program took up some time. Details can be found in the accompanying slides. Neil skilfully took participants through the new strategic priorities of Milton Keynes' Creative and Cultural Strategy for 2022-23.

It was noted that all grant applications MUST demonstrate that they meet the Cultural Inclusion Priority (1) and at least one other of the following criteria (2 - 4):-

Cultural Inclusion and Diversity (slide 22) ; 2. Not Just Business as Usual (slide 23); 3. Collaborations and Partnership (slide 24); and 4. Working Citywide Cultural Offer (slide 25).

Neil further commented that (slide 26):-

EDI means the whole community regardless of age, sex, sexual orientation, ethnicity or religious belief;

EDI ensures fair treatment and opportunity for all;

It aims to eradicate prejudice and discrimination on the basis of an individual or group of individual's protected characteristics;

That protected characteristics are age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation; and

Allows fairness and opportunity within groups and engagement with community

Neil also indicated that:-

MKHA and member organisations needed to reassess their policies and procedures in light of 'EDI' - (slides 27 & 28);

That future grants will also need to comply with 'EDI' - (slide 29). The KEY thing will be the 'wording used in grant applications'; and

That next steps for MKHA is (slide 30):-

- MKHA policies and grant forms need to be reviewed and updated
- Small steps needed to encourage and support individual projects

NB: It is worth noting that we cannot change the world overnight.
